#### Correspondence to Receive and File

<u>CC 04-11-18</u> A letter from J. Houston and M. Higgins, Co-Chairs, Rail Advocacy in Lambton (RAIL) dated February 12, 2018 regarding high speed rail environmental assessment - Southwestern Ontario Counties.

RAIL has advocated towards the resumption of a regular passenger rail service between Sarnia and London and intermediate points. Recent media reports indicate a High Speed Rail (HSR) Environmental Assessment is in the process of being initiated in several Southwestern Ontario counties and municipalities. Sarnia-Lambton doesn't appear to be a direct recipient and/or participant in the current projected massive transportation projects, presently being proposed. Yet there is a need of connectivity at major transportation hubs along with other small Southwestern Ontario Communities. Therefore, RAIL proposes:

a) The County of Lambton support an alternative mode of transportation to high speed rail, in the form of an integrated high frequency rail-high performance rail plan to resolve the transportation needs of Sarnia-Lambton and Southwestern Ontario, without the long term, multiple consequences related to the institution of high speed rail. b) Now would be a prime time for the County of Lambton to remind the Ontario Minister of Transportation to include in the Environmental Assessment, a serious consideration toward replacement of the trackage removed in the late 1990's as a means of enhancing the economic and transportation needs of Sarnia-Lambton and Southwestern Ontario.

<u>CC 04-12-18</u> An email from Jennifer Turk, Clerk, Township of Adelaide Metcalfe dated February 23, 2018 regarding installation of digital overhead communication signs. The Council of the Township of Adelaide Metcalfe is calling on the Ontario Ministry of Transportation to install digital overhead communication signs at every exit along Highway 402 east of the City of Sarnia in the County of Lambton to the merge of Highway 402 at Highway 401 in the City of London to communicate with the travelling public by informing motorists of weather/road conditions, road closures, and reception centres during weather events and also to communicate everyday awareness objectives.

And furthermore, that the Ontario Ministry of Transportation investigate the installation of digital speed limit signs along all provincial highways which will assist in regulating an appropriate speed limit during weather events that cause poor visibility and for the safety of construction employees during road work.

Attached is a summary of all municipal requests for changes to the vacancy programs that have been submitted to the Minister of Finance to date. The summary will be updated periodically to include municipalities that submit a request for change to the programs by the August 1, 2018 deadline.

# Correspondence from Member Municipalities

<u>CC 04-15-18</u> A motion from Mike Bradley, Mayor, City of Sarnia dated March 21, 2018 requesting that the County of Lambton call upon the Government of Ontario, and all political parties, to formally grant municipalities and First Nations the authority to approve landfill projects in or adjacent to their communities. That in the case of a two-tier municipality, the approval be required at both the upper-tier and affected lower-tier municipalities and First Nations and further that the County of Lambton encourage all other municipalities in Ontario to consider this motion calling for immediate provincial action.

<u>#10:</u> Bradley/Broad: That the motion contained in correspondence item CC 04-15-18 be amended to include "Frist Nations" so it now reads:

WHEREAS municipal governments in Ontario do not have the right to approve landfill projects in their communities, but have authority for making decisions on all other types of development;

AND WHEREAS this outdated policy allows private landfill operators to consult with local residents, and municipal Councils, but essentially ignore them;

AND WHEREAS proposed Ontario legislation (Bill 139) will grant municipalities and First Nations additional authority and autonomy to make decisions for their communities;

AND WHEREAS the recent report from Ontario's Environmental Commissioner has found that Ontario has a garbage problem, particularly from Industrial, Commercial and Institutional (ICI) waste generated within the City of Toronto, where diversion rates are as low as 15%;

AND UNLESS significant efforts are made to increase recycling and diversion rates, a new home for this Toronto garbage will need to be found, as landfill space is filing up quickly;

AND WHEREAS municipalities and First Nations across Ontario are quietly being identified and targeted as potential landfill sites for future Toronto garbage by private landfill operators;

AND WHEREAS other communities should not be forced to take Toronto waste, as landfills can contaminate local watersheds, air quality, dramatically increase heavy truck traffic on community roads, and reduce the quality of life for local residents;

AND WHEREAS municipalities and First Nations should be considered experts in waste management, as they are responsible for this within their own communities, and often have decades worth of in-house expertise in managing waste, recycling, and diversion programmes;

AND WHEREAS municipalities and First Nations should have the exclusive right to approve or reject these projects, and assess whether the potential economic benefits are of sufficient value to offset any negative impacts and environmental concerns;

THEREFORE BE IT RESOLVED THAT the County of Lambton calls upon the Government of Ontario, and all political parties, to formally grant municipalities and First Nations the authority to approve landfill projects in or adjacent to their communities, prior to June 2018;

AND THAT in the case of a two-tier municipality, the approval be required at both the upper-tier and affected lower-tier municipalities and First Nations;

AND FURTHER THAT the County of Lambton encourage all other municipalities in Ontario to consider this motion calling for immediate provincial action.
