<u>Auditor's Presentation</u>

Mr. Pete Barnes, CPA, CA, Partner, and Ms. Gale Koehler, CPA, CA, Senior Manager, BDO Canada LLP, provided an overview of the draft audited Financial Statements of The Corporation of the County of Lambton.

<u>Items for Discussion</u>

2022 Consolidated Financial Statements

The Auditors of BDO Canada LLP presented The Corporation of the County of Lambton's 2022 Consolidated Financial Statements and Trust Funds Statements.
