The County of Lambton, in conjunction with Clean Harbours Canada Inc., hosts several HHW collections events each year. The events give Lambton County residents an opportunity to properly dispose of potentially dangerous waste from their homes and protect our environment at the same time. If hazardous products are thrown in with the regular garbage, it can injure sanitation workers and cause long-term environmental problems.

HHW Days take place at the Clean Harbours Canada Inc. site, 4090 Telfer Road in St. Clair Township the last Saturdays of March, April, May, June, September, and October.

Bring your household derived hazardous wastes to the special depot, and it will be dealt with by experts, ***at no cost to you!***
