 - ii. acquire lands, within the City of Sarnia and/or Village of Point Edward, suitable to accommodate the Project, provided that the Agreements require both Committee A.M. and Committee P.M. to approve the terms and conditions thereof on or before January 20, 2021, and that if such approval is not secured by such date the Agreements shall terminate without any obligation and/or liability on the part of the County; and
 - if the conditions in paragraph a. immediately above are satisfied, issue a Request for Proposal (RFP) for the design, engineering and construction of the Project.
- c) That Staff report on its progress on the matters noted in paragraphs a) and b) above at Council's February 3, 2021 meeting.
